After working in Dubbo, NSW, I was able to continue to see many of my patients and work with the GPs whom I had built a relationship with- but through the medium of video consultation. I am primarily doing consultations for Dementia and Chronic Pain. The consultations take place in rural NSW.

**Consultant Rehabilitation Physician** (June 2014-December 2017) Changi General Hospital, Singapore

I was working in a team of 6 Rehabilitation Physicians with a caseload of approximately 50 inpatients between us, approximately 30 referrals each week and daily outpatient clinics. The patient load was largely neurological rehabilitation including strokes, brain injuries and spinal cord injuries but also includes orthopaedic and amputee rehabilitation, deconditioning, cardiac and pulmonary rehabilitation. I also worked in the Memory Service and run two clinics per month. I established a Transitional Living Unit and a Self Administration of Medicine Programme on the Rehabilitation Ward. During my time at Changi I cared for over 500 inpatients; and over 1500 outpatient visits.

I was a faculty member for both Undergrad and Post grad Teaching, acting as The Undergraduate Posting Coordinator, The Morbidity and Mortality Committee Chairman and received a Silver Caring Reward.

**Consultant Rehabilitation Physician (**December 2012-June 2014) Alexandra Hospital, Singapore.

I was working as a Rehabilitation Physician with a caseload of approximately 12 patients- primarily with Neurological conditions such as Stroke, Brain Injury and Spinal Cord Injury but also patients requiring Pulmonary Rehabilitation and Rehabilitation for Deconditioning. The service was new and I was responsible for growing the service, educating staff, and for analysing the service and advising on changes that would be required to grow the service into one with 76 beds and a great breadth of clinical diversity.

I worked with 2 other Rehabilitation Physicians and a multidisciplinary team caring primarily for Orthopaedic Rehabilitation patients who had had either hip or knee replacements. I was responsible for leading the team of allied health staff and facilitating the coordinated care of the patient during their stay and a timely discharge. Towards the latter part of my time I worked with the NUM to expand our capacity and cared for Cardiac and Deconditioned patients also.

**Visiting Rehabilitation Physician and Director of Rehabilitation Unit** (February 2011-July 2012)

Dubbo Private Hospital, Dubbo, NSW

I was caring for a 6-10 bed ward of geriatric rehabilitation patients- primarily with Orthopaedic, Neurological injuries/ illnesses and deconditioning. I headed up a multidisciplinary team coordinating the care of this group of complicated patients with multiple medical comorbidities. I was also running an outpatient clinic each week in Dubbo with an emphasis on dementia and other geriatric conditions such as falls. In addition, I did a lot of work with chronic musculoskeletal conditions such as low back pain, and other chronic pain syndromes.

**Employed initially as Service Manager in Preventive Health (**June 2008-February 2011)

Recovre, Sydney

I was taken on to develop preventive medicine/ health check- up services for Recovre including Executive Health Assessments. In June 2009 I took on the role as National Manager Corporate Health and assumed managerial responsibilities for a team of 6 support staff and a large number of doctors.

Concurrently, I continued with clinical work in the field of Occupational Rehabilitation. My major clinical clients included:

- 1. NSW Police for whom I coordinated and monitored the medical recruitment process and made all final decisions regarding fitness for recruitment. I supervised the work of all other doctors assisting with this work.
- 2. A large state government provider of health care services for whom I developed and implemented an Early Injury Intervention Programme. This programme identified those of their employees at high risk of developing chronic pain syndromes following a musculoskeletal injury at work. Intervention then included Specialist Medical Consultation (myself) and liaison with the treating General Practitioner, and focussed Psychological Therapy dealing with locus of control and pain management issues. The programme effectively reduced time off work and the associated costs for the employer.
- 3. I worked with the Allied Health stream of our business to assist in the management of injured workers and regularly consulted clients with regards to work fitness, both compensable and non-compensable. I worked most closely with

two large federal government organisations in this role and was also responsible for supervising the work of all other specialist doctors assisting with this work.
