This is voluntary Plastic Surgery in the Pacific, the surgery being performed by a team of 2 surgeons, an anaesthetist and a theatre nurse over a 2 week period of a purely voluntary basis. The aims of Interplast are

- Practical plastic surgical care by the Interplast team 2
- Stimulating local interest in the importance and scope of plastic surgery
- Teaching and training of local medical, nursing and health care staff
- Sponsoring further training of selected medical personnel in Australia
- Treating selected patients with difficult medical problems in Australian hospitals.

To date I have participated in 50 such missions over a period of 30 years. I have

been to New Guinea, Fiji, Kiribati, the Cook Islands on 6 occasions, and the Solomon Islands on 3 occasions, Vanuatu on 2 occasions and the Philippines on 8 occasions. I have personally performed more than 500 cleft lip and palate operations in the Philippines, radically changing the lives of these young children.

In November 2003, by invitation, I was part of an assessment team to Islamabad and Peshawar in Northern Pakistan to assess how Interplast may help deal with the victims of acid burns as a result of honour crimes.

In August 2008, 4-day emergency trip to Mwanza, Tanzania to reconstruct upper and lower eyelids for a 7 year old girl who was extremely badly burned and going blind.

In August 2012 I went to Kathmandu in Nepal to assess the need to establish an emergency management of severe burn injury course there.

Harman 1,2 Langerhans cells (LC) are thought to be the only mononuclear phagocyte population in the epidermis where they detect pathogens. Here, we show that CD11c+ dendritic cells (DCs) are also present. These cells are transcriptionally similar to dermal cDC2 but are more efficient antigen-presenting cells. Compared to LCs, epidermal CD11c+ DCs are enriched in anogenital tissues where they preferentially interact with HIV, express the higher levels of HIV entry receptor CCR5, support the higher levels of HIV uptake and replication and are more efficient at transmitting the virus to CD4 T cells. Importantly, these findings are observed using both a lab-adapted and transmitted/founder strain of HIV. We also describe a CD33low cell population, which is transcriptionally similar to LCs but does not appear to function as antigenpresenting cells or acts as HIV target cells. Our findings reveal that epidermal DCs in anogenital tissues potentially play a key role in sexual transmission of HIV.
