Parker G, Hilton T, Hadzi-Pavlovic D, **Bains J** (2001). Screening for depression in the medically ill: the utility of a cognitive-based approach in a new case-finding instrument. *Australian and New Zealand Journal of Psychiatry* 35(4):474-480.

Our cognitive-based measure is based on cognitions and was compared to the BDI and HADS in a heterogenous sample of medical inpatients. My role was to assist in the design of the both the study and our measure, recruit patients, conduct a clinical interview and administer the CIDI. This work has lead to 2 publications, the first reporting on the development of the screening measure and the second a full-scale study of the measures properties and utility in sample of over 300 medical inpatients, using my clinical judgement as the criterion measure.

**Bains J** and Vassilas C (1999). Carers of people with dementia: their experience of ward rounds. *Aging and Mental Health* 3(2): 184-187. Questionnaires were administered over the telephone to 67 carers of dementia sufferers who had attended an in-patient ward-round in a district general hospital. The majority of carers found that attending the ward-round was a positive experience. Attention needs to be paid to explaining the purpose and composition of the ward-round to prospective attenders. Routine enquiry as to carers' views is important in any old age psychiatry service and using telephone questionnaires is a useful method to gather this information.

**Bains J** (1998). From reviving the living to raising the dead: the making of cardiac resuscitation. *Social Science and Medicine* 47(9): 1341-1349. A Latourian interpretation of the making of cardiac resuscitation, the analysis revealing that the more successful cardiac resuscitation became as a fact the more it failed as a medical manoeuvre. An explanation is offered for this paradox. Work subsequently supported by the work of Professor Hillman on medical emergency teams at Liverpool Hospital (NSW).
